
I. KEY INDICATORS

- The Air transport industry in Romania was represented by 88 companies at the end of 2016, compared to 88 in the previous year and 82 in 2014.
- The industry's net loss amounted to RON 141,752,031 in 2016.
- The industry's total revenue was RON 1,531,296,851 in 2016, down by 46.50% compared to the previous year.
- The combined costs of the companies in the Air transport industry reached RON 1,670,416,536 in 2016, down by 42.16% year-on-year.
- The industry's total revenue makes up 0.16% to the country's Gross domestic product (GDP) in 2016, compared to 0.33% for 2015 and 0.29% in 2014.
- A total of 2,706 people were employed in the Air transport industry in 2016, compared to 3,371 in 2015 and 2,982 in 2014.
- Most of the companies in the industry are based in Bucharest, followed by Ilfov and Brasov.

II. INTRODUCTION

In 2016 the companies in the Air transport industry numbered 88, distributed in 3 sectors.

INDUSTRY STRUCTURE BY SECTORS AND NUMBER OF COMPANIES




In 2015 there were a total of 88 companies operating in the industry. In 2014 their number totalled 82.

III. REVENUES


The total revenue in the industry was RON 1,531,296,851 in 2016, RON 2,862,113,562 in 2015 and 2,348,708,600 in 2014.



The companies in the Air transport market of Romania earned combined net sales revenues of RON 1,336,362,057 in 2016.

In annual terms, sales marked a drop of 45.22% compared to 2015. In comparison to 2014 they fell by 37.57%. In 2015 sales fell by 13.98% year-on-year.


The Air transport industry total revenue make up 0.16% to the country's GDP in 2016, compared to 0.33% for 2015 and 0.29% in 2014.



We expect, based on the trend in the last three years, the total revenue of the Air transport industry to change at a compound annual growth rate (CAGR) of -19.26% in 2017.

Passenger air transport contributed net sales revenue of RON 1,254,156,121 or 93.85% of the total net sales in the industry, sector Freight air transport - RON 82,181,321 (6.15%), and sector Space transport - RON 24,615 (0.00%).

INDUSTRY'S NET SALES REVENUE STRUCTURE BY SECTORS



The highest growth, of 2.76%, was recorded by Freight air transport, while Passenger air transport registered the sharpest decline, of 46.85%.

The total revenues of the top 10 companies in the Air transport were 0.16% of GDP in 2016, compared to 0.32% for 2015 and 0.28% in 2014.

The top 10 by assets in the Air transport market made up RON 1,186,321,533, or 88.77% of the total net sales revenue.

The 10 largest companies in terms of total revenue in sector Air transport earned total revenue of RON 79,624,978 and accounted for 5.20% of the industry's total revenue.


IV. EXPENSES

The combined costs of the companies in the Air transport industry reached RON 1,670,416,536 in 2016.

In annual terms, total expenses decreased by 42.16% compared to 2015 and fell by 32.93% in comparison to 2014.

We expect, based on the trend in the last three years, the total costs of the Air transport industry to change at a compound annual growth rate (CAGR) of -18.10% in 2017.

Passenger air transport reported the highest total costs, of RON 1,591,427,621, followed by Freight air transport with RON 78,957,575 and Space transport with total costs of RON 31,340.



Space transport marked the highest annual increase in total expenses, of 64.76%, while total expenses went down the most, by 43.36%, for Passenger air transport.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 1, including TAROM SA. Below 5% threshhold are 87 companies, including AVIRO AIR SRL, AERO VIP REGIONAL SERVICES SRL, NIPPON EXPRESS DEUTSCHLAND GMBH MONCHENGLADBACH - SUCURSALA TIMISOARA, OLYMPIC AIR SA ATENA SUCURSALA BUCURESTI, ASHIFA AVIATION SERVICES SRL.

Employment expenses in the Air transport industry dropped by 12.44% on the year to RON 270,189,612 in 2016.

The highest growth in labour costs, of 15.59%, was registered by Freight air transport, while Passenger air transport marked the sharpest fall, of 13.30%.

The monthly costs per employee in the Air transport industry averaged RON 8,321 in 2016, RON 7,628 in 2015 and RON 7,536 in 2014.







About 50.00% of the 10 leading companies in terms of net profit per employee are located in Ilfov, while 30.00% are Bucharest-based and 10.00% are headquartered in Valcea.

The average net sales revenue per employee in the Air transport industry amounted to RON 493,851 in 2016, down by 31.76% compared to 2015 and down by 31.20% compared to 2014.

The Air transport market generated an average RON 565,889 in total revenue per employee. In 2015 and 2014 the figure was RON 849,040 and RON 787,629, respectively.

The average total revenue per company in the Air transport industry went down to RON 17,401,101 in 2016 from RON 32,524,018 in 2015. The 2014 value was RON 28,642,788.

A company in the Air transport sector made on average a net sales revenue of RON 15,185,932 in 2016, compared to RON 27,724,190 in 2015 and RON 26,103,285 in 2014.

The Air transport industry made 0.11% of the overall sales country-wide, reducing its market share by 0.10 pp.




