


I. KEY INDICATORS

- The Motion picture, video and television programme production, sound recording and music publishing activities industry in Romania was represented by 2,412 companies at the end of 2016, compared to 2,147 in the previous year and 1,920 in 2014.
- The industry's net profit amounted to RON 149,620,631 in 2016.
- The industry's total revenue was RON 1,582,567,652 in 2016, up by 8.75% compared to the previous year.
- The combined costs of the companies in the Motion picture, video and television programme production, sound recording and music publishing activities industry reached RON 1,407,644,129 in 2016, down by 2.13% year-on-year.
- The industry's total revenue makes up 0.17% to the country's Gross domestic product (GDP) in 2016, compared to 0.17% for 2015 and 0.20% in 2014.
- A total of 4,170 people were employed in the Motion picture, video and television programme production, sound recording and music publishing activities industry in 2016, compared to 4,360 in 2015 and 4,185 in 2014.
- Most of the companies in the industry are based in Bucharest, followed by Ilfov and Cluj.

II. INTRODUCTION

In 2016 the companies in the Motion picture, video and television programme production, sound recording and music publishing activities industry numbered 2,412, distributed in 5 sectors.







In 2015 there were a total of 2,147 companies operating in the industry. In 2014 their number totalled 1,920.



The total revenue in the industry was RON 1,582,567,652 in 2016, RON 1,455,234,160 in 2015 and 1,604,049,314 in 2014.



The companies in the Motion picture, video and television programme production, sound recording and music publishing activities market of Romania earned combined net sales revenues of RON 1,445,523,286 in 2016.

In annual terms, sales marked an increase of 11.68% compared to 2015. In comparison to 2014 they went up by 4.44%. In 2015 sales went up by 6.48% year-on-year.

The Motion picture, video and television programme production, sound recording and music publishing activities industry total revenue make up 0.17% to the country's GDP in 2016, compared to 0.17% for 2015 and 0.20% in 2014.




We expect, based on the trend in the last three years, the total revenue of the Motion picture, video and television programme production, sound recording and music publishing activities industry to change at a compound annual growth rate (CAGR) of -0.67% in 2017.

The total revenues of the top 10 companies in the Motion picture, video and television programme production, sound recording and music publishing activities were 0.07% of GDP in 2016, compared to 0.06% for 2015 and 0.09% in 2014.

The top 10 by assets in the Motion picture, video and television programme production, sound recording and music publishing activities industry made up RON 477,352,989, or 33.02% of the total net sales revenue.

IV. EXPENSES


The combined costs of the companies in the Motion picture, video and television programme production, sound recording and music publishing activities industry reached RON 1,407,644,129 in 2016.

In annual terms, total expenses fell by 2.13% compared to 2015 and dropped by 13.71% in comparison to 2014.

We expect, based on the trend in the last three years, the total costs of the Motion picture, video and television programme production, sound recording and music publishing activities industry to change at a compound annual growth rate (CAGR) of -7.11% in 2017.

Sound recording and music publishing activities marked the highest annual increase in total expenses, of 22.92%, while total expenses went down the most, by 11.62%, for Motion picture, video and television programme production activities.

The biggest spenders in the industry, with costs of over 10% of industry's costs, numbered 10, including PROROM DISTRIBUTION SRL, VERTICAL ENTERTAINMENT SRL, ICON FILMS SRL, ABIS STUDIO SRL, FAMILY FILM ENTERTAINMENT SRL. The medium spenders, or those in the 5% and 10% range count 16 and include INTACT PRODUCTION SRL, UNIVERSAL MUSIC ROMANIA SRL, ODEON CINEPLEX SRL, STUDIOSET PRODUCTION SRL, SCHUBERT MUSIC PUBLISHING SRL. Below 5% threshhold are 2,386 companies, including STUDIO N.I.C SRL, FORMULA 1 - CONTINENTAL SRL, TARGET MEDIA SRL, APERTURE STUDIO SRL, AV MEDIA PRODUCTIONS SRL.

Employment expenses in the Motion picture, video and television programme production, sound recording and music publishing activities industry fell by 1.39% on the year to RON 139,782,937 in 2016.

The highest growth in labour costs, of 24.61%, was registered by Motion picture, video and television programme post-production activities, while Motion picture, video and television programme distribution activities marked the sharpest fall, of 13.42%.

The monthly costs per employee in the Motion picture, video and television programme production, sound recording and music publishing activities industry averaged RON 2,793 in 2016, RON 2,709 in 2015 and RON 2,543 in 2014.



About 60.00% of the 10 leading companies in terms of net profit per employee are located in Bucharest, while 30.00% are lasi-based and 10.00% are headquartered in Ilfov.

The average net sales revenue per employee in the Motion picture, video and television programme production, sound recording and music publishing activities industry amounted to RON 346,648 in 2016, up by 16.77% compared to 2015 and up by 4.81% compared to 2014.

The Motion picture, video and television programme production, sound recording and music publishing activities industry generated an average RON 379,513 in total revenue per employee. In 2015 and 2014 the figure was RON 333,769 and RON 383,285, respectively.

The average total revenue per company in the Motion picture, video and television programme production, sound recording and music publishing activities industry decreased to RON 656,123 in 2016 from RON 677,799 in 2015. The 2014 value was RON 835,442.

A company in the Motion picture, video and television programme production, sound recording and music publishing activities field made on average a net sales revenue of RON 599,305 in 2016, compared to RON 602,879 in 2015 and RON 720,877 in 2014.

The Motion picture, video and television programme production, sound recording and music publishing activities industry made 0.12% of the overall sales country-wide, increasing its market share by 0.01 pp.


VI. EMPLOYMENT
